#### A RESOLUTION ON ELECTRONIC VOTING AT FACULTY ASSEMBLIES (22/1)

- **WHEREAS**, Article II, Section 3(c) of the Faculty Organization Plan provides "A quorum for any meeting shall consist of 125 members of the membership of the Assembly;"
- WHEREAS, Article II, Section 3(d) of the Faculty Organization Plan provides "The Assembly shall act by affirmative vote of a majority of members present and voting, unless the action proposed is in adverse review of action taken by the Senate, in which case the affirmative vote of two-thirds of the members present, or one representing a majority of the membership of the Assembly, whichever is the lesser, shall be required;"
- WHEREAS, at the Fall 2020 online meeting of the Assembly, it was the determination of the Parliamentarian, accepted by the President as Chair of the Assembly, that while those members attending virtually (in accordance with the terms of the meeting) would be deemed present for purposes of any quorum requirement, "present" for purposes of Article II, Section 3(d) meant physical presence in a meeting room, such that the Assembly could vote only if it were permitted to do so by unanimous consent;
- WHEREAS, circumstances may require that future regular and special Assemblies may be convened virtually, and technological developments have facilitated virtual participation and voting in ways that approximate physical presence, and differ meaningfully from the kind of absentee or proxy voting that a presence requirement continues to foreclose; and
- WHEREAS, any regular or special Assembly meeting otherwise conforming to the Faculty Organization Plan and the Rules of Procedure for Faculty Assembly Meetings should be permitted to conduct business of the kind contemplated by those instruments without requiring the unanimous agreement of all those participating;

# NOW, THEREFORE, BE IT RESOLVED BY THE FACULTY SENATE OF THE GEORGE WASHINGTON UNIVERSITY

That the sense of the Senate is that, whenever a regular or special Assembly meeting is called at which virtual attendance is permitted, either exclusively or as an alternative to in-person attendance, members who are virtually present—in accordance with the criteria announced for that meeting—shall be deemed present for purposes of quorum and voting.

#### Issues Discussed/Actions Taken

Fall 2020 discussions centered around three areas: Campus safety during the pandemic; Thurston Hall renovations; HVAC issues in residence halls and academic buildings.

#### **Campus Safety**

Over the summer the focus was on how to create and improve signage for a return to campus, measuring spaces to comply with CDC standards for physical distancing to determine which would be usable. As the summer came to a close and the decision was made to remain virtual for the fall semester, the conversation changed to safety protocols for COVID testing, and managing the small number of students who would be allowed on campus. Details of these discussions can be found in the Interim Report submitted in December 2020.

#### Thurston Hall Renovation

The committee met with relevant administrators to understand the three phases of work related to Thurston. These are rebuilding the outer structure, utility work upgrades; improving the streetscape. The committee learned about the size and quality of rooms, bathrooms, and sustainability concerns.

Regarding the structure, the main focus was on rebuilding the elevator footing. Double rooms will be the main portion of the building, at 89%. New public-private bathrooms have been built in each corner of the building, with 3-5 private spaces and at least one ADA compliant bathroom per bathroom space. The entire building will be LEED Gold certified, and a part of this sustainability work will be a cistern on the roof which will hold 20K gallons of water. The entire project is on time and on budget, at approximately \$108 million.

#### **HVAC** Upgrades

All campus buildings have been evaluated for air-handling equipment, protocols for a re-start, and a rating system was created for all campus buildings. Some of the HVAC issues pre-dated the pandemic and the goal has been to modernize as much as is possible. Monies have been set aside in the FY2022 budget to address many of these upgrades.

The committee learned that all buildings are safe in terms of health. However, a tiered system was developed with newer buildings being in a high suitability category, another tier in a medium suitability category, and a third in a low suitability category. Most of the low suitability buildings are the townhouses. The current press is to bring as many of the buildings that are in the highest area of the low suitability category to medium suitability. For example, eight residence halls were evaluated in the spring semester to determine how to optimize them for the fall and all were improved. An additional eight buildings had work done; seven of these were academic and one was a residence hall. Of the eight, three had outdated equipment and could not be moved from low to medium (Building GG, Phillips, and the Philip Amsterdam House). The others were brought to medium suitability. The next focus of attention will be to modernize Funger (high medium), Duques (high medium), and the Law School.

By the end of summer an additional 17 buildings will be worked on and at least half of them will be completed by then.

As this work continues, the committee will receive monthly updates. The committee had questions about inclusion of all campuses in the upgrade work and this was confirmed. Additionally, a fact sheet will be created to provide information on project progress.

#### Mitchell Hall

The next residence hall renovation will be to update Mitchell Hall. A committee was formed and the chair of Physical Facilities is part of the project planning competition. Decisions will be made by the end of spring semester.

#### Planning for Fall 2021

A new committee was formed from two of last year's committees; this new committee is charged with preparing for a full return in fall of 2021. The new committee is called Campus Spaces and Events. Weekly meetings are planned for the duration of the spring and into the summer. Two members of the Physical Facilities Committee will be a part of these weekly meetings.

The Physical Facilities Committee had representatives meeting with administration and with Senate leadership to provide discussion and question and answer sessions on all the above topics.
